### **REGIONAL DISTRICT OF OKANAGAN-SIMILKAMEEN**

### **BYLAW NO. 1620, 1995**

A bylaw to transfer the Naramata community water utility and to establish a local service for the supply, treatment, conveyance, storage and distribution of water in and for the community of Naramata, within Electoral Area E.

**WHEREAS** by a public consultation process and by resolution of the Trustees of the Naramata Irrigation District dated June 29, 1995, the Regional District of Okanagan-Similkameen has been requested to accept the transfer of the Naramata community water utility;

**AND WHEREAS** by resolution dated July 20, 1995, the Board of Directors of the Regional District of Okanagan-Similkameen has accepted, in principle, the Naramata community water utility as a local service of the Regional District;

**AND WHEREAS** pursuant to Section 788(1)(b) of the *Municipal Act*, the Regional District of Okanagan-Similkameen may, by bylaw, establish and operate as a local service, the supply, treatment, conveyance, storage and distribution of water;

**AND WHEREAS** the Board of Directors of the Regional District of Okanagan-Similkameen wishes to proceed under section 794 of the *Municipal Act* to establish the supply, treatment, conveyance, storage and distribution of water as a local service for the Naramata Water System Local Service Area in Electoral Area E as outlined on Schedule A attached to this bylaw;

**AND WHEREAS** the provincial government, pursuant to sections 826 and 773 of the *Municipal Act*, has enacted Order-in-Council No. 1219 dated September 28, 1995, to effectively dissolve the Naramata Irrigation District and transfer all assets of that body to the Regional District of Okanagan-Similkameen;

**AND WHEREAS** the Director of Electoral Area "E" has consented in writing to the adoption of this bylaw;

**NOW THEREFORE** the Board of Directors of the Regional District of Okanagan-Similkameen, in open meeting assembled, ENACTS as follows:

#### ESTABLISHMENT OF LOCAL SERVICE

1.0 The Naramata Water System Local Service is hereby established as a local service and shall be known as the "Naramata Water System Local Service Area".

## WATER SYSTEM LOCAL SERVICE

2.0 The Board of Directors of the Regional District of Okanagan-Similkameen is empowered and authorized to provide for the supply, treatment, conveyance, storage and distribution of water in and for the Naramata Water System Local Service Area, and without limiting the generality of the foregoing, to enter into contracts with such authorities and companies as may be necessary or appropriate to implement the Naramata Water System Local Service.

## **BOUNDARIES OF THE LOCAL SERVICE AREA**

3.0 The boundaries of the Naramata Water System Local Service Area are within a portion of Electoral Area E as outlined on Schedule A attached to and forming part of this bylaw.

# PARTICIPATING AREA

4.0 The Naramata Water System Local Service Area is located entirely within the boundaries of Electoral Area E.

# **COST RECOVERY METHOD**<sup>1</sup>

- 5.0 The annual costs for the Naramata Water System Local Service shall be recovered pursuant to Sections 803(1)(a), (b) and (c) of the *Local Government Act* as follows:
  - (a) by the requisition of money in the local service area as established by this bylaw, to be collected by a property value tax on the net taxable value of land and improvements within the local service area, to be levied and collected in accordance with Division 4.3 of Part 24 of the *Local Government Act*.
  - (b) by the requisitioning of money in the local service area established by this bylaw, to be collected by a parcel tax, to be levied and collected in accordance with Division 4.3 of Part 24 of the *Local Government Act*.
  - (b) by the imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs.

# LIMIT<sup>2</sup>

6.0 The maximum amount that may be requisitioned under Division 4.3 of Part 24 of the *Local Government Act* for the Naramata Water System Local Service shall not exceed \$839,800.00.

## **CITATION**

7.0 This bylaw may be cited for all purposes as the <u>Naramata Water System Local Service</u> <u>Establishment Bylaw No. 1620, 1995</u>.

# APPORTIONMENT OF LIABILITY

8.0 Notwithstanding Section 1 of Bylaw No. 1700, and Section 2 of Bylaw Nos. 1808, 1876 and 2118, any amount required to settle the liabilities of the former Naramata Irrigation District

shall continue to be apportioned only among those properties which were within the Naramata Irrigation District immediately prior to its dissolution on September 28, 1995. This section is not severable from the remainder of this bylaw.<sup>3,4,5,6</sup>


