GENERAL CONDITIONS

- 3. Where there is a conflict between the text of the permit and permit drawings or figures, the drawings or figures shall govern the matter.
- 4. This Development Variance Permit is not a Building Permit.

5. This Development Variance Permit is substantially in accordance with Schedules 'A', 'B', 'C', and applies to and only to those lands within the Regional District described below, and any and all buildings, structures and other development thereon:

CONDITIONS OF DEVELOPMENT

- 6. The land specified in Section 5 may be developed in accordance with the following variances to the Okanagan Valley Zoning Bylaw No. 2800, 2022, in the Regional District of Okanagan-Similkameen:
 - a) the minimum front parcel line setback for a accessory structure in the Agriculture One (AG1) Zone, as prescribed in Section 13.1.5(c)(i), is varied:

i) from: 7.5 metres

to: 6.62 metres to the outermost projection as shown on Schedule 'B'.




