## A Bylaw to amend the Electoral Area 'E' Naramata Area Official Community Plan Bylaw No. 2458, 2008

The REGIONAL BOARD of the Regional District Okanagan-Similkameen in open meeting assembled, ENACTS as follows:

- 1. This Bylaw may be cited for all purposes as the "Electoral Area 'E' Naramata Area Official Community Plan Amendment Bylaw No. 2458.03, 2011."
- 2. The Official Community Plan Bylaw Map, being Schedule 'B' of the Electoral Area 'E' Official Community Plan No. 2458, 2008, is amended by changing the designation on the land shown blue hatched on the attached Schedule 'Y-1', which forms part of this Bylaw, from part Low Density Residential (LR) to part Conservation Area (CA).
- 3. The Official Community Plan Bylaw Map, being Schedule 'B' of the Electoral Area 'E' Official Community Plan No. 2458, 2008, is amended by changing the designation on the land shown blue hatched on the attached Schedule 'Y-2', which forms part of this Bylaw, from part Large Holdings (LH) to part Small Holdings (SH).
- 4. Section 7.3.2 be amended by adding:
  - i. and that Lot A, Plan KAP58675, District Lot 3474, SDYD and an approximate area 400 m south from the northern property line and 65 m east from the west property line of District Lot 3474, Except Plans KAP 44343, KAP 59640, KAP 53674, SDYD located at 3480 Arawana Forestry Road be exempted from the requirement to complete a Comprehensive Development Plan.

Read a Third time as amended this 1<sup>st</sup> day of September, 2011.


