Why an OCP?



- It is a bylaw, but its high level and helps guide the RDOS
- Outlines vision to external agencies, neighboring communities & jurisdictions
- Helps align future projects with the community's vision
- Establishes a framework for future regulation (should it be required) or supports minimal regulation if preferred

How will it affect me directly?

- X Bring about a surge of development
- X Regulate buildings on my private property
- X Increase my taxes

- Provide direction to the RDOS & other Agencies
- Have a say in what you want to see for the future
- ✓ Support community values
- Lead to future initiatives

83% of respondents were permanent, full time residents.

What needs attention.



- Unkept properties
- Illegal dumping
- Limited services and infrastructure
- Unreliable telecommunications

- Poor water quality
- Limited arts & culture venues
- Loss of local businesses
- Safety concerns speeding, buildings in disrepair, crime

What's changed.

- Less housing availability
- Increased number of people moving here

- More businesses closing
- Increased wildfire and flooding events
