CONDITIONS OF DEVELOPMENT

6. The land specified in Section 5 may be developed in accordance with the following variances to the Electoral Area "H" Zoning Bylaw No. 3065, 2024, in the Regional District of Okanagan-Similkameen:

a) the minimum exterior side parcel line setback for a accessory building in the Low Density Resdential One (RS1) Zone, as prescribed in Section 16.1.5(a)(iv), is varied:

i) from: 3.0 metres

to: 2.15m metres to the outermost projection as shown on Schedule 'B'.

- 9. The development shall be carried out according to the following schedule:


