**A Bylaw to amend the Electoral Area “A” Zoning Bylaw No. 2451, 2008**

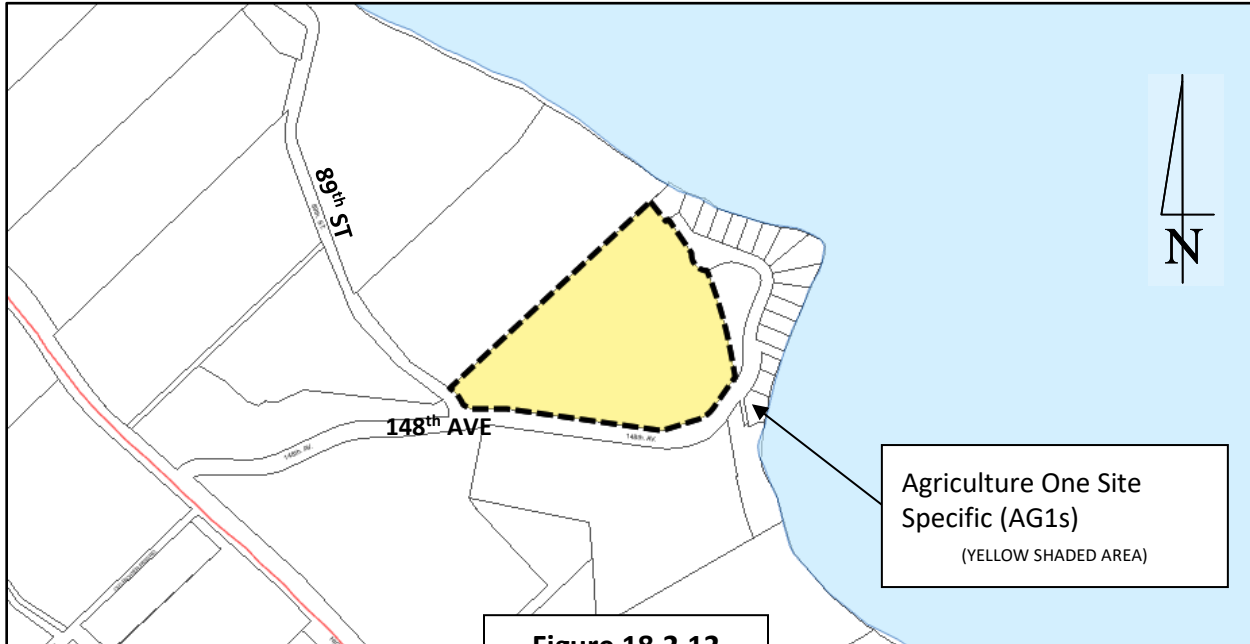

The REGIONAL BOARD of the Regional District of Okanagan-Similkameen in open meeting assembled, ENACTS as follows:

1. This Bylaw may be cited for all purposes as the “Electoral Area “A” Zoning Amendment Bylaw No. 2451.33, 2022”.
2. The “Electoral Area “A” Zoning Bylaw No. 2451, 2008” is amended by:
  - i) adding a new sub-section .12 under Section 18.2 (Site-Specific Agricultural One (AG1s) Provisions) to read as follows:

.12 In the case of land described as Lot 1, Plan KAP59513, District Lot 2450S, SDYD, and shown shaded yellow on Figure 18.2.12:

    - a) despite Section 7.16.3, the maximum number of agri-tourism accommodation sleeping units permitted on the land described in 18.2.12 is ten (10).

The Official Zoning Map, being Schedule '2' of the Electoral Area "A" Zoning Bylaw No. 2451, 2008, is amended by changing the land use designation on the land described as Lot 1, Plan KAP59513, District Lot 2450S, SDYD, and shown shaded yellow on Schedule 'A', which forms part of this Bylaw, from Agriculture One (AG1) to Agriculture One Site Specific (AG1s)

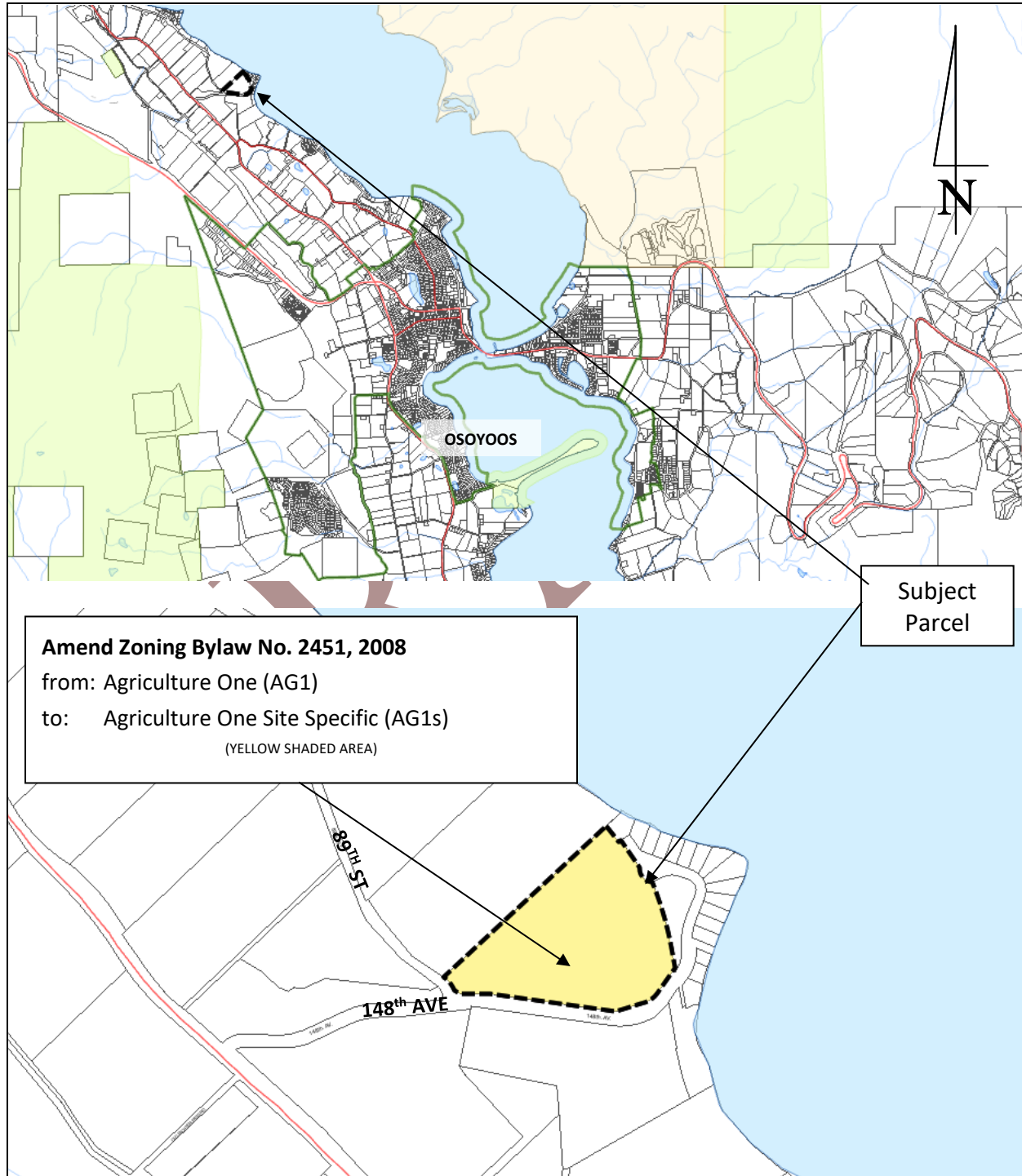
