**A Bylaw to amend the Okanagan Valley Zoning Bylaw No. 2800, 2022**

---

The REGIONAL BOARD of the Regional District of Okanagan-Similkameen in open meeting assembled, ENACTS as follows:

1. This Bylaw may be cited for all purposes as the “Okanagan Valley Zoning Bylaw Amendment Bylaw No. 2800.16, 2022.”
2. The “Okanagan Valley Zoning Bylaw No. 2800, 2022,” is amended by:
  - i) adding a new sub-section (ii) under Section 13.1.8 (a) (Agriculture One Site Specific (AG1s) Regulations - Electoral Area “A”) to read as follows:

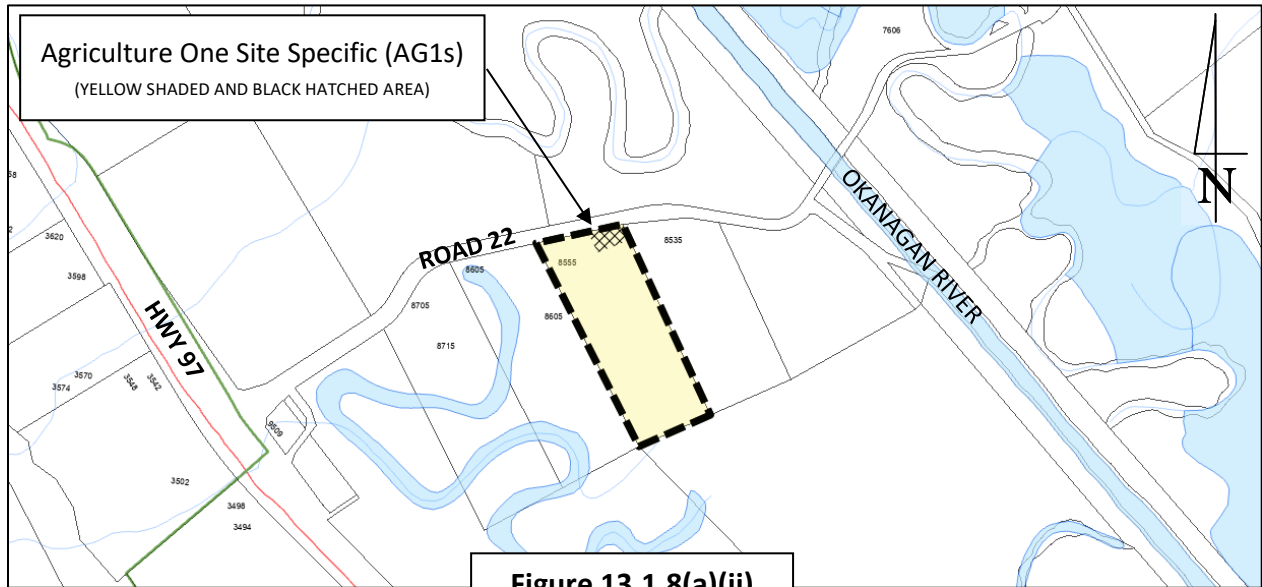


Figure 13.1.8(a)(ii)

  - ii) in the case of approximately 0.16 ha portion of the land described as Lot 3, Plan KAP51250, District Lot 2450S, SDYD (8555 Road 22), and shown shaded yellow and hatched black on Figure 13.1.8(a)(ii):
    - a. the following accessory use shall be permitted on the land in addition to the permitted uses listed in Section 13.1.1:
      - i. “campground” for up to ten (10) recreational vehicle sites.

The Official Zoning Map, being Schedule '2' of the "Okanagan Valley Zoning Bylaw Amendment Bylaw No. 2800.16, 2022", is amended by changing the land use designation on approximately 0.16 ha portion of the land described as Lot 3, Plan KAP51250, District Lot 2450S, SDYD (8555 Road 22), and shown shaded yellow and hatched black on Schedule 'A', which forms part of this Bylaw, from Agriculture One (AG1) to Agriculture One Site Specific (AG1s).

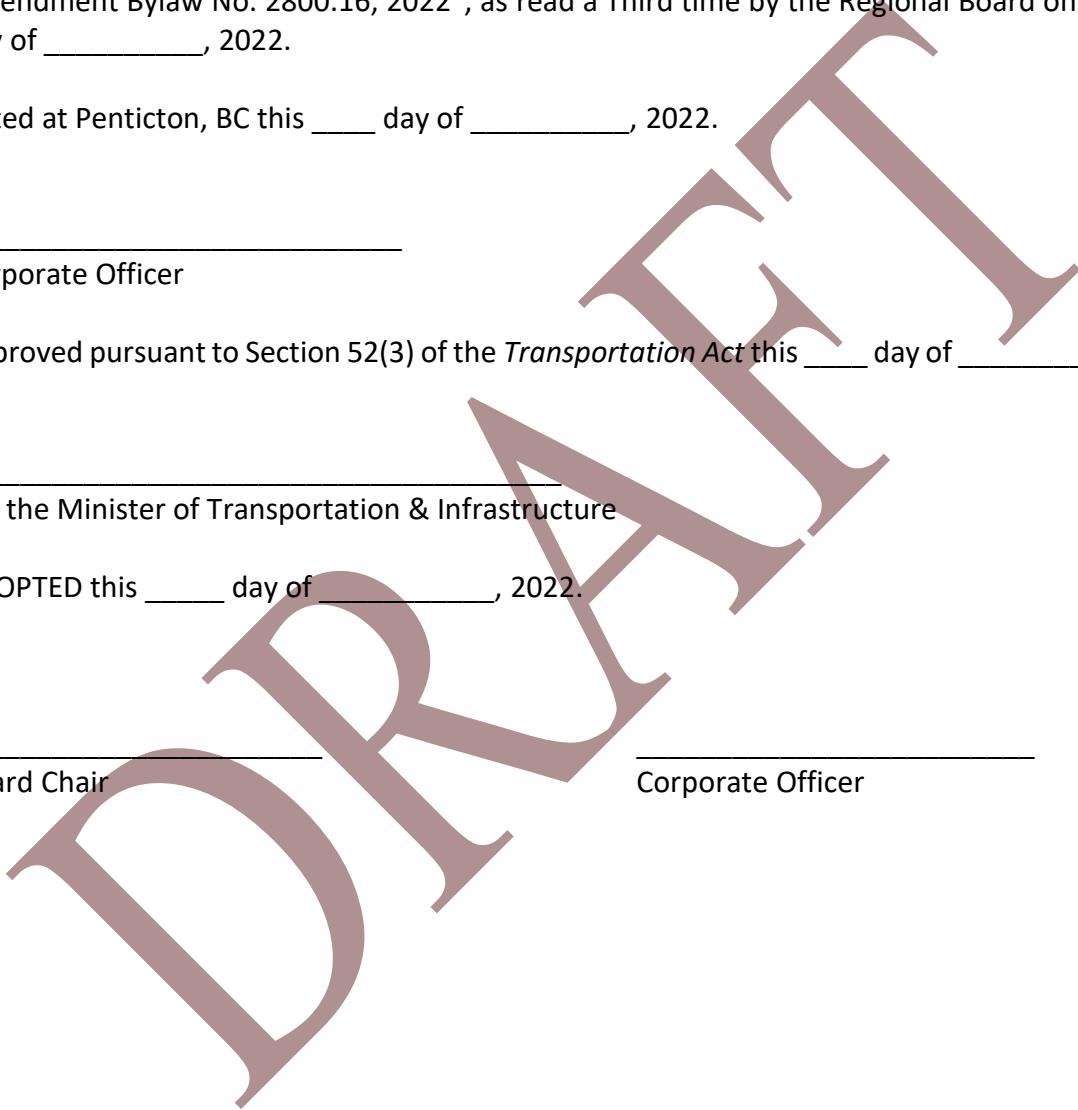

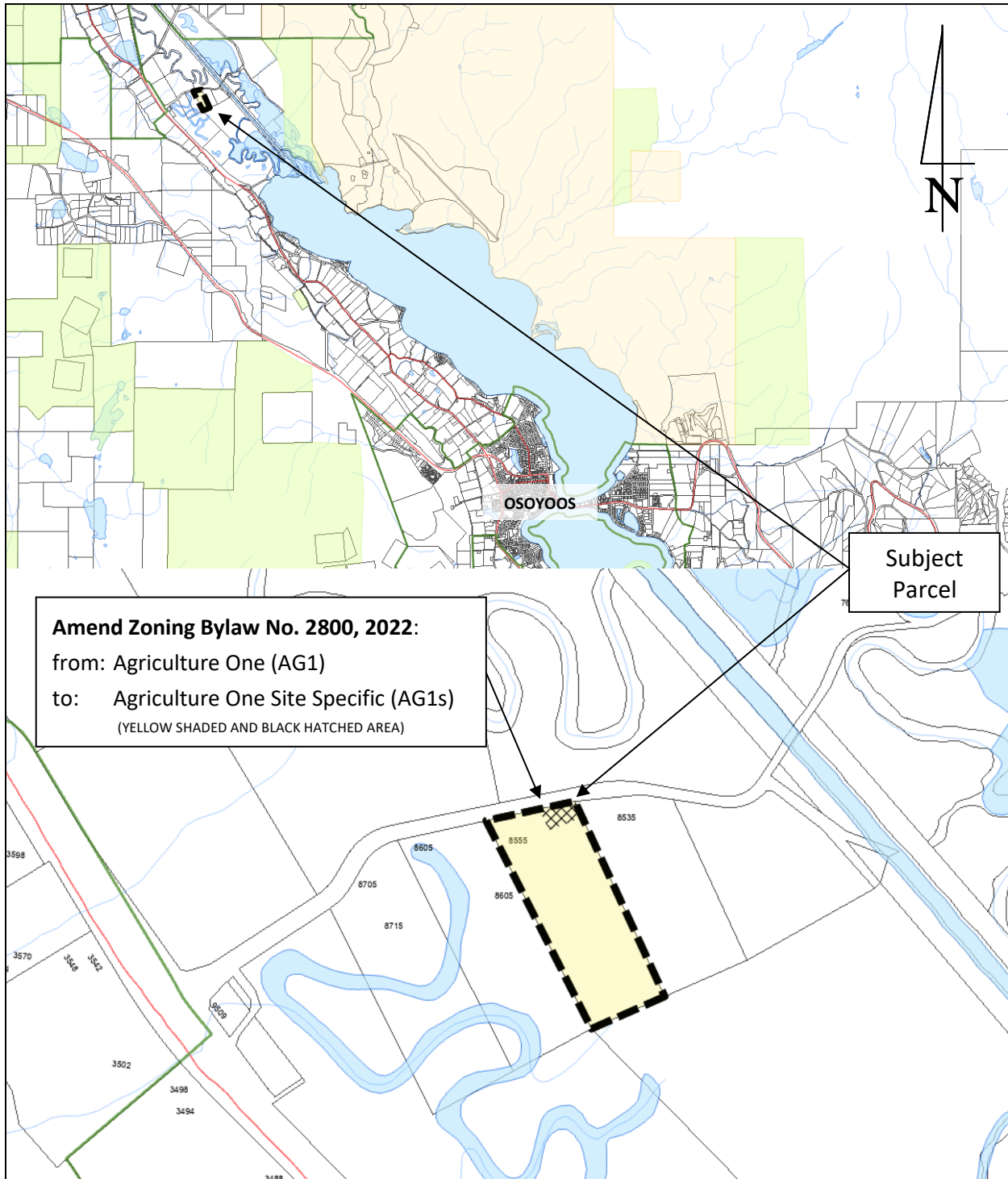
