#### **GENERAL CONDITIONS**

 This Development Variance Permit is issued subject to compliance with all of the bylaws of the Regional District of Okanagan-Similkameen applicable thereto, except as specifically varied or supplemented by this Permit.

- 3. Where there is a conflict between the text of the permit and permit drawings or figures, the drawings or figures shall govern the matter.
- 4. This Development Variance Permit is not a Building Permit.

#### **APPLICABILITY**

5. This Development Variance Permit is substantially in accordance with Schedules 'A', and 'B', and applies to and only to those lands within the Regional District described below, and any and all buildings, structures and other development thereon:

#### **CONDITIONS OF DEVELOPMENT**

- 6. The land specified in Section 5 may be developed in accordance with the following variances to the Okanagan Valley Zoning Bylaw No. 2800, 2002, in the Regional District of Okanagan-Similkameen:
  - a) the minimum front parcel line setback for an accessory building in the Low Density Residential Three (RS3) Zone, as prescribed in Section 16.3.5(b)(i), is varied:
    - i) from: 7.5 metres

to: 1.82 metres to the outermost projection as shown on Schedule 'B'.


