## GENERAL CONDITIONS

1. This Temporary Use Permit is issued subject to compliance with all of the bylaws of the Regional District of Okanagan-Similkameen applicable thereto, except as specifically varied or supplemented by this Permit.
2. The land described shall be developed strictly in accordance with the terms and conditions of this Permit, and any plans and specifications attached to this Permit which shall form a part thereof.
3. Where there is a conflict between the text of the permit and permit drawings or figures, the drawings or figures shall govern the matter.
4. This Temporary Use Permit is not a Building Permit.

## APPLICABILITY

5. This Temporary Use Permit applies to, and only to, those lands, including any and all buildings, structures and other development thereon, within the Regional District as shown on Schedules 'A', and 'B' and described below:

## TEMPORARY USE

6. In accordance with Section 20.0 of the Electoral Area "C" Official Community Plan Bylaw No. 2452, 2008, the land specified in Section 5 may be used for the residential use of a "recreational vehicle", as defined in the Okanagan Valley Zoning Bylaw, being a vehicle designed to be towed behind a motor vehicle or selfpropelled, and includes such vehicles commonly known as travel trailers, fifth wheels, camper trailers, pick-up coaches,

motorized campers, motorized homes, park model trailers and other similar vehicles, which provide temporary recreational accommodation for the traveling public.

**CONDITIONS OF TEMPORARY USE**

- 7. The residential use of a recreational vehicle on the land is subject to the following conditions:
  - a) A maximum of one (1) recreational vehicle shall be permitted for residential use.
  - b) The recreational vehicle shall be in the form of a Canadian Standards Association Z240-RV model recreational vehicle.
  - c) The recreational vehicle shall be connected to the on-site septic system and well.

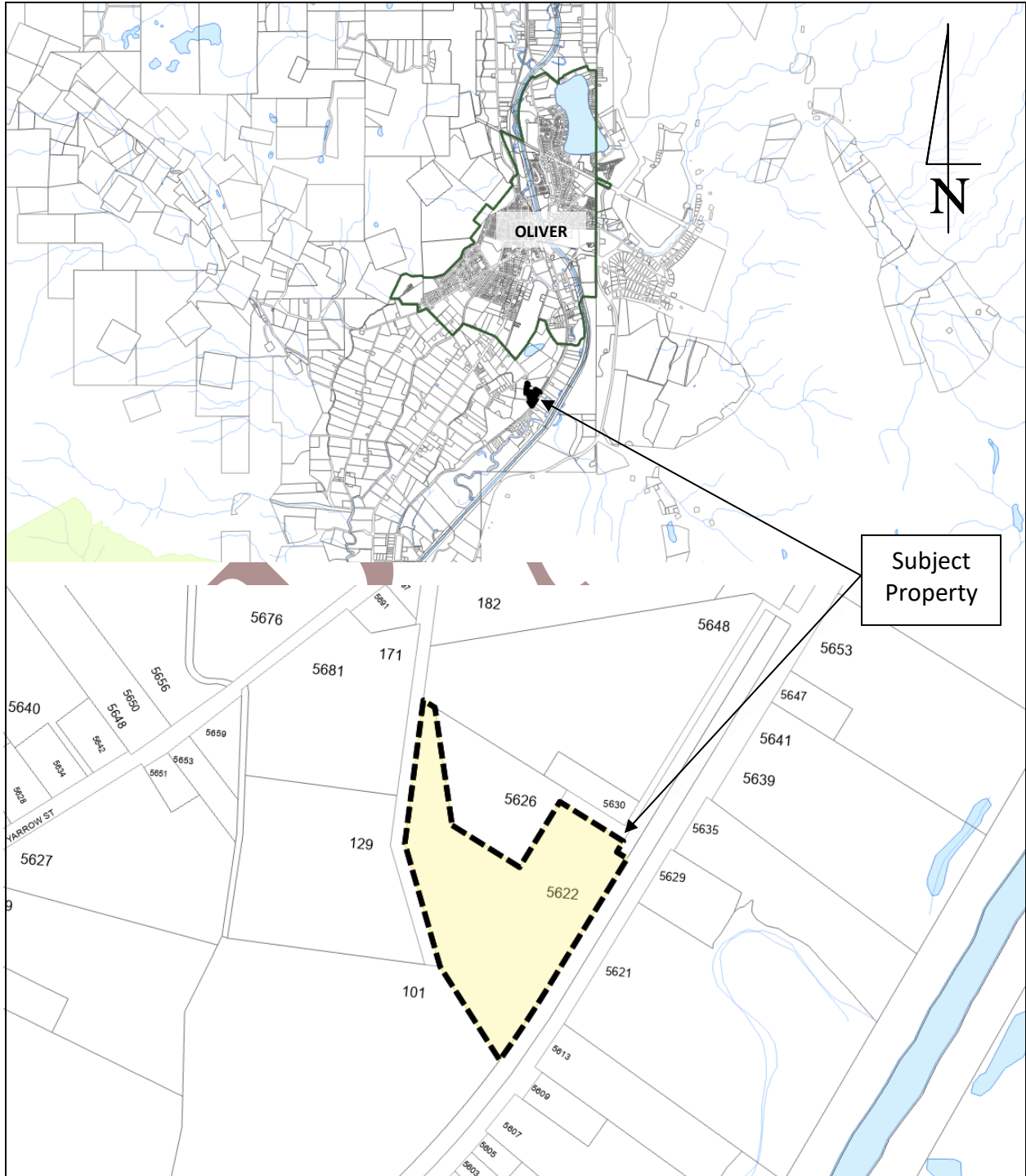
