- 2. The land described shall be developed strictly in accordance with the terms and conditions and provisions of this Permit, and any plans and specifications attached to this Permit that shall form a part thereof.
- 3. Where there is a conflict between the text of the permit and permit drawings or figures, the drawings or figures shall govern the matter.
- 4. This Development Variance Permit is not a Building Permit.

CONDITIONS OF DEVELOPMENT

- 6. The land specified in Section 5 may be developed in accordance with the following variances to the Electoral Area "E" Zoning Bylaw No. 2459, 2008, in the Regional District of Okanagan-Similkameen:
 - a) the minimum rear parcel line setback for a principal building in the Low Density Residential Two (RS2) Zone, as prescribed in Section 12.2.6(a)(ii) is varied:
 - i) from: 7.5 metres

3.0 metres to the outermost projection as shown on Schedule 'C' to: b) the maximum parcel coverage in the Low Density Residential Two (RS2) Zone, as prescribed in Section 12.2.8, is varied: from: 35% ii) to: 39.3% **COVENANT REQUIREMENTS** Not Applicable **SECURITY REQUIREMENTS** Not applicable **EXPIRY OF PERMIT** The development shall be carried out according to the following schedule: In accordance with Section 504 of the Local Government Act and subject to the terms of the permit, if the holder of this permit does not substantially start any construction with respect to which the permit was issued within two (2) years after the date it was issued, the permit lapses. b) Lapsed permits cannot be renewed; however, an application for a new development permit can be submitted.
