Products derived from the keeping of livestock and honeybees may be sold in accordance with Section 7.17 (Home Occupation) or Section 7.18 (Home Industry) of this bylaw, in addition to any applicable provincial regulations.</li> <li>4. Products derived from the keeping of <i>livestock</i> and honeybees may be sold in accordance with Section 7.6 (Home Industry) of Section 7.7 (Home Occupation) of this bylaw, in addition to any applicable provincial regulations.</li> <li>4.
